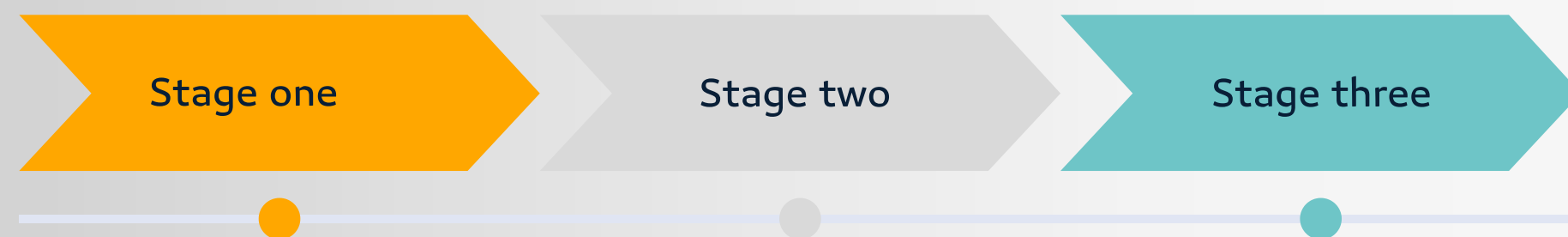


COMPANY REGISTRATION STAGES

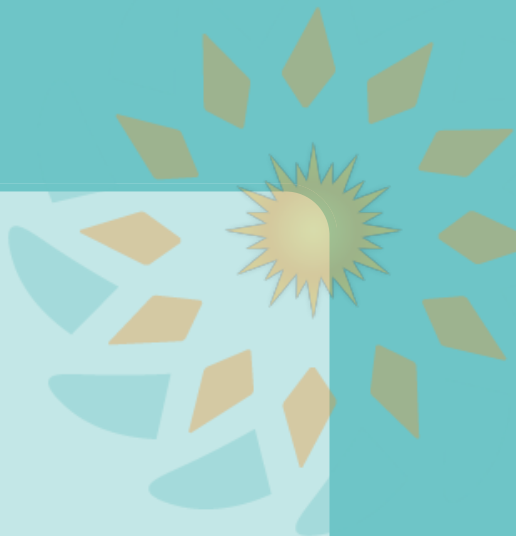
